Interview Questions

Patients at First Level Health Facility (FLHF) and Referral Hospital (RH)

- 1. Have you experienced any difficulties in obtaining referrals to referral hospitals? If yes, why did the doctor at the FLHF not issue a referral?
- 2. Were you referred to a specific hospital, or were you free to choose the hospital you preferred? Why didn't the doctor refer you to a different Referral Hospital under the JKN (BPJS) system?
- 3. How does the patient referral process work from a FLHF or clinic to a hospital that serves patients under the JKN?
